#### Summary 1st Session

131th Legislature (2023-2024)

First Regular Session

- LD #665 "An Act to Extend the Date by Which Compliance is Required for Affordable Housing Development, Increased Numbers of Dwelling Units and Accessory Dwelling Units" (AGAINST) May 10, 2023 ONTP
  - To adequately address all Town Meeting communities and the 20 communities with a mixed Town Meeting-Council form of government, we recommend the implementation date be postponed to September 1, 2024 for municipalities that amend their zoning ordinance by Town Meeting. However, this extension should not apply to other communities that are able to more quickly and easily amend zoning ordinances.
- LD #887 "An Act to Amend the Regulation of Mobile Home Parks" (SUPPORT) Jan 18, 2024 ONTP
  - ° The increase in investment-owned parks has resulted in a dramatic increase in lot rents across the country. At the same time, manufactured housing parks that are not investment-owned but owned by the tenants themselves (resident owned communities) have been shown to be the only existing model of home ownership attainable by families making an average of \$40,000 with no subsidy.
- LD #1934 "Resolve, to Improve the Coordination and Delivery of Planning Grants and Technical Assistance to Communities in Maine" (SUPPORT) Passed
  - "Study of the existing system for funding and delivering planning services, and devising recommendations to reform and improve it, are worthwhile endeavors."

#### Summary 1st Session

131th Legislature (2023-2024)

First Regular Session

- LD #1931 "An Act to Foster Stable and Affordable Home Ownership in Mobile Home Parks by Amending the Laws Relating to the Sale of Mobile Home Parks" (SUPPORT) Passed
  - "It ensures, when there is a sale of a manufactured housing community, that the residents will get a reasonable opportunity to know about the sale and to have enough time to decide if they want to make an offer to the seller and to obtain financing."
- LD #1154 "An Act Regarding Accessory Dwelling Units and Municipal Zoning Ordinances" (AGAINST) May 18 2023 ONTP
  - "The proposed bill creates an unnecessary, unproductive barrier to the creation of ADUs. It will delay or deny housing choice by limiting production of ADUs to those municipalities that affirmatively allow them, instead of allowing them outright."
- LD #1358 "An Act to Clarify Density Requirements for Affordable Housing Developments" (SUPPORT) May 18 2023 ONTP
  - "When the Affordable Housing Density Bonus was established by LD 2003 in the last legislative session, it was clearly the intent that a majority of the new housing created would be affordable. This bill aligns the text of the law more clearly with the intent."



#### Summary 1st Session

131th Legislature (2023-2024)

First Regular Session

- LD #1634 "An Act to Grant Municipalities the Authority to Set Certain Lower Motor Vehicle Speed Limits Without a Department of Transportation Speed Study" & LD #527 "An Act to Allow Municipalities to Create Bicycle and Pedestrian Zones with Reduced Speed Limits" (SUPPORT) May 16 2023, Feb 8 2024 ONTP
  - "It would remove an unneeded barrier to reduced speed zones by eliminating the requirement for expensive, time consuming, and potentially counterproductive speed studies."
- LD #214 "An Act to Amend the Laws Regarding Zoning and Land Use Restrictions to Limit Certain Requirements to Municipalities with a Population of More than 10,000" (AGAINST) May 18, 2023 ONTP
  - "This is not the time to limit affordable housing options, but rather the time to expand the breadth of opportunities."
- LD #487 "An Act to Establish Coastal Waters and Submerged Lands Regional Planning Commissions" (<u>NEITHER FOR NOR AGAINST</u>) April 5, 2023 ONTP
  - o "MAP supports the general concept. However, it is unclear why it would be necessary to create new regional planning commissions (RPCs) when we already have existing, state law enabled regional planning commissions that have a long history of dealing with coastal issues"

2nd Session

- LD # 1976 "An Act to Update the Growth Management Program Laws" (NEITHER FOR NOR AGAINST)
  - "We support a process, of finite length, where either the Housing Committee or a Stakeholder group undertakes a review of the Growth Management Laws and Rule." Jan 26, 2024 Work Session Held TABLED
- LD # 772 "An Act to Establish a Process to Vest Rights for Land Use Permit Applicants" (NEITHER FOR NOR AGAINST)
  - "We recognize the need to find balance between a community's right to protect its interests through ordinance amendments and the private sector's rights to protect its investments in pursuing development." Feb 13, 2024 Work Session Reconsidered TABLED
- LD # 337 "AN ACT TO AMEND THE REGULATION OF MANUFACTURED HOUSING TO INCREASE AFFORDABLE HOUSING" (SUPPORT) Jan 30, 2024 OTP
  - o "The vast majority of mobile homes have been providing affordable housing on <u>individual lots</u> in the form of single family homes or Accessory Dwelling units (ADUs). This bill will prevent local zoning from discriminating against this affordable housing type by allowing manufactured housing (defined as HUD certified post 1976 mobile homes and state certified modular homes) to be erected anywhere single family homes are allowed and subject to the same rules."
