John Adams is the Director of the Vermont Center for Geographic Information, where he is focused on democratizing data and building a culture of openness across government. He previously served as Planning and Policy Manager at the Agency of Commerce and Community Development and worked in the field of land use planning for a decade in Vermont and abroad. John is the primary author of Vermont's Planning Manual and has taught Land Use Policy and Economics at University of Vermont. John grew up in Montreal and currently lives in Montpelier, where he volunteers on the planning commission. He holds a Masters of Urban and Regional Planning from Queen's University and a BA in Environment and Development from McGill University.

Matt Boulanger is the Planning Director for the Town of Williston, Vermont. Matt has worked for Williston since 2008 and has been the Planning Director since 2018. Matt holds a bachelor's degree in Environmental Studies from Saint Lawrence University and a Master's in Sustainable Transportation from the University of Washington. Matt grew up in nearby Monkton and now lives in South Burlington with his wife and son. Matt is fascinated by the challenges facing Williston through its planning program, including how to meet demands for growth while achieving mobility, equity, affordability, and conservation goals.

Christian Brandt is a Planner and Community Engagement Specialist at MAPC where his work focuses on creating opportunities for participatory, collaborative, and meaningful community engagement and community self-determination in urban planning.
